BCH, BCI, REDACTED, that REDACTED should consider
no marriage partner - and REDACTED BCK could
do same (once free)

sexual relations sufficient to divorce, free himself &
REDACTED no contact now makes

- BCH considers this a good idea. Tells him that
BCK has liked him etc.

Incest of [BCH] & [BCG] now exposed - [BCJ] phones

meet with all concerned. Events develop when [BCH]

 was serious enough that [REDACTED] broke down emotionally.

 seemed only one of a number of problems involved.
 More encouragement is needed here with every fresh
 discussion. [REDACTED] still seemed determined to separate,
 even for a little while.

Baron when **REDA CTED** asked if **BCH** could continue staying with the children & was asked not to go ahead with that but do it herself. **BCH** felt & expressed some opposition to it. We felt that to counsel **BCH** in his actions before **REDA CTED** about their personal contact & don't think may impress on mind & heart of persons concerns of principle of conscience of bias & so + John's views on "counseling".

12.6.79 with **BCI** again, further impressed need to break any contact with **REDA CTED**. We felt there was strong feeling when she went over counsel. She asked if John held any possibility of with **REDA CTED** after divorce. We again reiterated suggestions strongly not to consider it but break contact, advising that even if **REDA CTED** may make further contact, she should stop it at once and employing us to approach **REDA CTED** in quiet.

Informed us **BCH** had told them of his intention of protection of

leaving family & now association on [BCI] part.
Mentioned Mr. [BCI] as man on which to proceed in divorce.

[BCH] has asked Mr. [BCI] hospital for any records of V.D.
and his past & perhaps on [BCI] too - for both would
have had to be treated; if this was really the case.
Attitude of [BCH] was very calm, deliberate as if all planned,
according to [REDACTED]

Definitely had told [REDACTED] of having V.D.!!

Interesting that both mentioned BCK as admitting to
another "attempt" of molesting by BCH when going to
school at later age (primary?) tried to check statement.
Quest: Should one be studying with younger children?
- even for short time until things settle?

BCH took BCK hand to place it on her private parts

 Our discussions as Judicial Committee also involved
 removal of privileges for [REDACTED] [BCH] over their
