Submission Text: I was an active publisher of the Jehovah's Witnesses organization for 55 years; until a group of elders took it upon themselves to judge me as "unfit to be a JW". As a veteran instructor of Biblical theology and principles of conduct for over 30 years as an elder, ministerial servant and public speaker; I understood the Biblical reasons why we, if at all, would choose to expel a member publicly. While they invoke 'scriptural reasons' for choosing to shun their members; I can tell you that in most cases it's a matter of the overseers or elders' personal opinions and the corporate offices 'personal interpretations' of what constitutes a "sin", when they decide to expel and shun a member. In order to be reinstated, you have to request it in writing and then meet with same men to explain why you're sorry for what you did and how; if at all you've changed your behavior.
